Oral Health Promotion Clearinghouse


This has been an exciting time to take up a role with the Clearinghouse. Ongoing activities of developing and maintaining the website, planning a biennial consensus workshop and contributing to the National Strategy on Oral Health Promotion have continued. It has been a particularly busy time with upgrade to the website to improve accessibility, especially for users who use screen reading software. The next consensus workshop, which will focus on oral health promotion processes, is planned for 2016.

Collaborative research ICOHIRP

Professor Marco Peres attended the International Centre for Oral Health Inequalities Research and Policy (ICOHIRP) Launch Conference in London on Thursday 21 May 2015. The ICOHIRP was formed in 2014. Committed to tackling oral health inequalities both within and between countries, academics and policy makers from 15 countries have formed a global network to explore the nature and cause of oral health inequalities to inform future policy. The launch conference was held at the Royal College of General Practitioners in partnership with Public Health England. Professor Peres was invited to present on Psychosocial determinants of oral health and was involved in editing the brochure, 'Social inequalities in oral health: from evidence to action'. It is intended that the conference will be held every two years.

PhD student updates

PhD completions



Congratulations to Sue Gardner who was awarded her PhD with a Dean's commendation for 'Doctoral Thesis Excellence'. The title of Sue's thesis is 'Exploration of dentists characteristics associated with caring for disadvantaged patients, using a mixed-methods approach'. Her supervisors were Professor Kaye Roberts-Thomson, Associate Professor Tracey Winning and Associate Professor Ray Petersen. The main findings were that dentists initial career choice motivation, religious affiliation, type and location of practice were associated with a practice orientation toward disadvantaged patients. However empathy and resilience, key themes from the qualitative study, and socio-economic factors, demographics and dental school experiences were not associated.



In May Kostas Kapellas was awarded his PhD titled, 'Investigation of non-surgical periodontal treatment effect on arterial stiffness, a surrogate marker of cardiovascular disease'. Kostas PhD was supervised by Associate Professor Lisa Jamieson, Associate Professor Loc Do and Professor Mark Bartold. His thesis used a parallel-group randomised controlled design to investigate whether non-surgical periodontal therapy influenced central arterial stiffness in a sample of Indigenous Australian adults with moderate to severe periodontal disease. Cross-sectional analysis of baseline data revealed that there was a dose-dependent linear association between pulse wave velocity (PWV) with increasing severity of periodontal disease. This association attenuated with systolic blood pressure suggesting that the

aetiology of arterial stiffening is strongly influenced by hypertension in this population. A single untimed session of non-surgical periodontal therapy resulted in clinically marginal improvements of shallow periodontal pockets and reduced gingival bleeding for the treatment group compared to control but did not significantly influence PWV.

New PhD student: Ninuk Hariyani



Ninuk Hariyani received her doctor degree of dental surgery (DDS) from The Faculty of Dentistry, Airlangga University in Indonesia, in 2003. Since 2006, she has been appointed as a lecturer in the same institution and worked in the Department of Dental Public Health. In 2011, she got an Australian Development Scholarship to pursue a Master of Public Health degree at The University of Adelaide. Her master's project, 'Root Caries and Exposure to Fluoridated Water among Australians Adults' was done at ARCPOH. She finished her master degree in 2012 and went back to Indonesia as a lecturer. In 2014, Ninuk obtained a PhD scholarship from the Indonesian government. The aim of her PhD research at ARCPOH is to study the root caries experiences across generations among Australians. Ninuk's research areas

of interest include public health, oral epidemiology, the measurement of oral diseases, quality of life, social inequalities and oral health surveillance.
